1. Emails to the AEC inbox that appear to be spam may be blocked. *It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.*
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

Nominations cannot be withdrawn after 4pm (AEST) on 12/08/2025.

Candidate Statements

Candidates may submit a statement to be included with ballot material. Such a statement must not exceed **two hundred (200)** words containing only the candidate's personal history and/or policy statement, may include a passport size photograph and be in **Microsoft Word format**.

Only statements which comply with the Rules and are received by the Returning Officer by 4pm (AEST) on 5/08/2025 are accepted.

Voting Period

The ballot, if required, will open on 02/09/2025 and close at 12:00 noon (AEST) on 01/10/2025.

Scrutineer Appointment

The appointment of scrutineers opens 15/07/2025 and closes 12:00 noon (AEST) on 01/10/2025.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
