Access assistance and advice about teacher accreditation/registration; benefit from a range of free and discounted face-to-face, online, and on-demand PD.

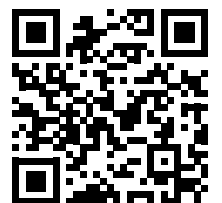
